

## Urban Confluence Silicon Valley Phase Two 2021 Schedule

Updated February 26, 2021

### Monday January 18: (MLK Holiday)

- Phase 2 submission deadline

### Tuesday January 19:

- Submissions given to Technical Review Team
- Technical Review Team uses "Submittal Checklist" to determine whether submissions are complete

### Thursday January 21 & Friday January 22:

- Technical testing for January 30 presentations for 3 teams

### Friday January 22:

- Technical Review Team report is given to Urban Confluence staff to determine if the 3 Finalists' teams complied with the Phase 2 Submission Requirements
- Submissions provided to the Jury only

### Tuesday January 26:

- Finalists receive final stipend payment of \$50,000 each

### Saturday January 30:

- Finalists make separate 45-to-60-minute presentations to the Jury with an additional 45 minutes of Q & A. The presenters will be given the opportunity to select their presentation duration (45-to-60-minutes) with encouragement to realize the benefit of added Q&A time. Presentations will be recorded and posted on the Urban Confluence Silicon Valley website (see Feb 1).
- The presentations will take place at the following times:

- The following people will be invited to participate:
  - (Groups 1 and Group 2 will view the presentations live using select on-line platforms) ○ **Group 1:** The Jury. ONLY the Jury and presenters will be visible to the audience and to each other. Presenters will not be interrupted with questions until their presentation is complete. Only the Jury will be allowed to ask questions during the Q&A following each presentation. Steve Borkenhagen and Christine Davis will be available representing Urban Confluence and Nicolle Burnham will be available representing the City of San Jose to answer questions if requested by Julia Czerniak. The exact process for asking questions is TBD.
  - **Group 2:** Mayor Sam Liccardo, District 3 City Councilman Raul Peralez, other city council members including their senior staff, city staff including city manager, Community Competition Panel (CCP) members, and select stakeholders. This group will be allowed to send questions to Steve Borkenhagen and Christine Davis during the presentations. Steve Borkenhagen and Christine Davis will filter the questions and send appropriate questions to Julia Czerniak (Jury chair) to ask the 3 Finalists' teams during the Q&A. Juror questions will be given exclusive priority.

**The following comes directly from City Manager Dave Sykes' memo to the San Jose City Council dated March 1, 2019:  
(the memo was unanimously approved by the City Council on March 12, 2019)**

"Following Phase 2, the jury will recommend a single preferred design to the SJLTC and the City Manager. The SJLTC and the City Manager will discuss the selection with their respective staff and environmental consultants, consider the outcome of the community input (see below) and make a recommendation to Council regarding acceptance of a final design."

"Once received by SJLTC, the Phase 2 submittals will be posted publicly with opportunity for the public to comment in a manner similar to that of Phase 1."

"Following review of the Phase 2 submissions by the jury a public community meeting will be held to present the recommended preferred design."

"Following the community meeting, the final selection will be presented to PAC, PRC and City Council."

The following dates have moved due to COVID:

"If endorsed by the City Council, the SJLTC will proceed with an International Ideas Competition in early 2019. The competition will take place during 2019, with a final selection occurring on or before January 31, 2020. Following completion of the competition, staff will return to Council with a recommendation for the preferred design and seek authorization for the SJLTC to proceed with design development. At that phase of the project, more details will be developed around capital funding for the project, construction strategies, and long-term operational models."
